What is New in MMOG/LE v5?



- Overview of the proposed improvements
 - <u>Alignment with IATF 16949</u> (e.g., corrective actions, supplier performance, cascading best practices and standards through the supply chain...)
 - More emphasis on <u>risk management</u> and contingency plans throughout the supply chain including a <u>cyber security</u> policy
 - A deeper alignment between strategies, <u>objectives</u> and continual improvement
 - More emphasis on minimizing or eliminating <u>skills gap</u>
 - Further emphasis on systems integration and leveraging the planning system
 - Strengthen the requirements in <u>Chapter 6: Supplier Interface</u> (e.g. supplier selection and assessment, use of supply chain metrics in assessment process...)
 - Strive to achieve the <u>electronic exchange of data</u> to 100% EDI
 - Adoption of <u>advanced technologies</u> (Industry 4.0...) to increase performance and efficiency





What is New in MMOG/LE v5?



- Chapter 1
 - Strategies and objectives (KPIs) sections were significantly strengthened
 - Aligned corrective actions with IATF 16949
 - More emphasis on continual improvement
 - New: Leverage advanced technologies in order to improve outcomes (e.g., skills gap, equipment failure)
- Chapter 2
 - New: Standardized work instructions for all SCM in the language and include rules for operator safety
 - Skills and qualifications required for each job function are documented
 - Assess employee opportunities for training
- Chapter 3
 - Streamlined and merged EDI questions in order for simplification
 - Integrated planning and scheduling system to clarify
 - The production planning system automatically generates supplier schedules





What is New is MMOG/LE v5?



- Chapter 4
 - More specific requirements on what needs to be communicated in a situation that negatively impacts the customer
- Chapter 5
 - Added more specifics around documentation required when the customer authorizes deviations from what was improved during PPAP (e.g., results of review, authorizations, actions, retain information)
- Chapter 6
 - NEW: The SCM agreement includes inventory policies based on customer requirements for long lead-time and critical parts
 - Strive to achieve 100% EDI/Web or meet customer requirement
 - Sub suppliers to be assessed for new product launch or performance review
